



Zion Lutheran Church January 22, 2023 2023 Annual Minutes

The Annual meeting of Zion Lutheran Church was called to order by President Steven Rust at 1:30 pm January 22, 2023. 22 members signed the attendance roster. Pastor Lee gave devotions from Acts and a prayer. Sue kipp made a motion to approve the agenda and Nathaniel Grote seconded the motion, and the motion was approved. Benny Bennight made a motion to approve the 2022 annual minutes, seconded by Dennis Keesee and the motion was approved.

Pastor Lee gave his report, Parochial report and read the letter from Bishop Elizabeth Eaton. Steven Rust gave his Congregation Council Report, he would like to thank the Congregation for all they do. Thank you to the people who do the snow removal. Dennis Keesee gave the Treasurer report. Dennis made a motion to renew the Living Lutheran magazine at the cost of \$375.00 per year. Karin Patton seconded the motion, and the motion was approved. Shellie Lare Made a motion to approve the Pastor report, Congregation report, and Treasurer report. Karin Patton seconded the motion and the motion was approved.

TEAM REPORTS: Congregation Ministry, Property, Worship & Music, and Trust Fund committee reports were reviewed and there is a great need for PMA's. Pastor would like to thank everyone who help with these committees.

Organizations: Janet McCall gave the WELCA report, and letting the congregation know that she is stepping down as President. The Congregation thanked her for many years of service.

OLD BUSINESS: New carpet and clavinova has been combined with committee members of Sue Kipp, LeAnn Driggs and Worship & Music team. Carpet fund will come out of the Now Account with a budget of \$3000.00 and budget of \$4000.00 for the clavinova.

NEW BUSINESS: Resolution, Pastor Lee read the letter sent by State Synod before the vote so the Congregation could vote accordingly. We would need 10% of voting members to be able to make the vote. Three volunteers need to count votes, Marcy Rust, Janet McCall and Karin Patton. Resolution #1-- Voting for Kathryn Ann Whitney, to be called to serve as minister of Word and Sacrament of the Disciples of the Plains Parish. The vote was called by ballet. Yes was at 21

votes and No was at 0. Karin Patton made the motion to approve the vote and Dennis Keesee seconded the motion, the motion was approved. Resolution #2--Shall the Disciples of the Plains council be authorized to negotiate the compensation package with Rev. Kathy Anne Whitney? The vote was called by voice and a Congregation majority was a yes. A motion was made by Dennis Keesee to approve this vote and seconded by Marci Rust, the motion was approved. Nathaniel Grote and Howard Kings' three year terms are up on council, they both have agreed to stay on for an another term. Marci Rust made a motion to accept both Nathaniel and Howard for another term, Bob Lamp seconded the motion and the motion was approved. Benny Bennight and Shellie Lare will attend the Synod Assembly June 3rd 2023.

The Congregation reviewed the Disciples of the Plains 2023 proposed budget. 2023 proposed financial budget was reviewed. JeanAnn Wagner made a motion to gift Lutheran World Relief \$2500.00 and the offering from Lent and Advent. Marci Rust seconded the motion and the motion was approved. Janet McCall made a motion to approve the 2023 financial goal and Nathaniel Grote seconded the motion and the motion was approved. Resolution #3—Adoption of Financial goal for 2023, Dennis Keesee made a motion to approve Resolution#3, and Sue Kipp seconded the motion and the motion was approved. Resolution #4— Thanksgiving, with a correction of Steven Rust to Nathaniel Grote. Ackowledgement was also given for those members who have passed away. A motion by Benny Bennight to approve the Resolution #4 seconded by Janet McCall and motion was approved. Bob Lamp made a motion to adjourn the meeting after the Lords Prayer and Jeff Griffey seconded the motion, motion was approved.

2023 Zion Pastor's Annual Report

Dear Zion Friends, Members, and Ministry Partners:

Grace and peace to you in the name of our Lord Jesus Christ.

WE ARE CHURCH.

As we reflect on 2023 and plan for 2024, we must remember that we **are** the church. During our Zoom Bible studies this year and the continuing studies by the councils from all four parish congregations, we have been using Rev. Kelly A. Fryer's book, **Reclaiming the "C" Word – Daring to be Church Again.** One point that Rev. Fryer makes very clear is that we do not "go to church," because going implies that we can also choose not to go. In our



baptism, we do not "go" to church, we are the church in all the wide variety of ways that entails.

And with the realities in which Zion must live giving shrinking membership and resources, realities that most churches in rural and inner-city areas also face, I would like the focus on this report to not simply be about people who go to church but people who are the church. For every one of you have been called in your baptism to be the church in the world. Your life, your vocations, your mission fields are those you touch every day. And as a congregation, our mission is not simply measured by numbers in worship but by how we have responded to the call to be the church in our community for the sake of the world.

ROSTERED MINISTRY DUTIES AS THE CHURCH

First, I need to provide you some statistics for the Word & sacrament ministry to which you have called me. In 2023, I made 462 pastoral contacts. A pastoral contact can be a phone call to check up on someone or a trip to an out-of-town hospital to visit a sick parishioner. I have led 47 classes of Bible study or confirmation. I have led or participated in 139 worship services. I have attended 67 congregational or parish meetings. And I have attended 11 synod meetings or events.

Almost all my continuing education was done on Zoom this year, which helped to keep costs and travel time down. I attended the Festival of Homiletics, which is a fancy word for "preaching," from May 15th through May 18th. The

Festival of Homiletics brings pastors from throughout the country and many different seminaries together for lectures, workshops, and worship. It is an inperson event with thousands attending each year. But ever since COVID, they have included on-line options. I also attended various synod gatherings, the Central States Synod Fall Theological Conference that focused on dialogue between Pentecostal and Lutheran Christians and attended two more Zoom classes regarding the year of Mark's gospel.

Even given this busy schedule, there were periods of time that I was unavailable due to illnesses and hospitalizations. Thank you for your support during these times, especially when both Pastor Kathy and I were ill at the same time. We both are doing very well right now. We anticipate and pray for a healthier 2024.

Pastor Kathy was officially called as a Word and sacrament minster of this parish on January 29th. Pastor Kathy and I have worked towards having a consistent and more frequent sharing of pulpits throughout the parish, which I feel is working. We have also done more collaborative projects together, such as the Longest Night Services this past Advent that were provided to help support those who struggle during the holiday season. We also gathered together to participate in a congregation vitality surveys conducted by the synod.

I continue to serve as co-dean of Central States Synod Western Kansas Conference. The duties of a dean are to help communication with the bishop regarding issues in the Western Kansas Conference, to provide synod representation when distance or other logistics prevent a synod representative from responding to a situation quickly, to help support other pastors in the conference, and be an advisor to the bishop's office when needed.

I was also appointed this year to be on the task force regarding the election of a new bishop. (I do not think we have an official name, yet). Bishop Susan Candea has announced that she will not be seeking a second term as bishop. Her current term ends in August 2025. Assistant to the Bishop Dave Whetter is also retiring. To provide some guidance and cultivate interest from qualified candidates, the task force is beginning to meet now to discuss what type of pastoral and leadership skills are needed from the next bishop. One good part of being on this task force is that I cannot be nominated for bishop.

I also continue to serve as a member of the Phillips County Ministerial Alliance. Through the PCMA, I take turns monitoring our aid phone called "The Care Phone." I regularly lead worship at Phillips County Retirement Center. I also did the research and helped the PCMA obtain the proper insurance needed for its operations, including the Food Pantry and commodities program.

MEMBERS OF ZION LUTHERAN ARE THE CHURCH

Turning now to more of how Zion is the church in our community, I offer these highlights from our ministry this year.

We have been blessed that Andrea Keesee has officially become a candidate for the Pastoral Ministry Associate program. PMAs work with rostered leaders either in their home congregations or parishes, or sometimes as the pastor of a congregation that has difficultly calling a Word and sacrament or Word and service minister. This is a three-year program and I urge us all to encourage Andrea as much as possible during her journey.

We said goodbye this past November to Deanna Ewing, who served as our office administrator for three decades. Issues of finances and allocation of resources led the Zion Council to terminate the office administrator position as of January 1st of this year, but Deanna's preference was to end her employment in November. We pray that she is happy and well in her new endeavors and are very thankful for her years of service.

One confirmation student from Zion, Drayden Simpson, attended confirmation camp at Tomah Shinga in Junction City from June 18th through the 23rd. He was joined by me and two students from Emmanuel: Jhett Johnson and Blayne Johnson. Zion did not have any students affirm their baptism in 2023. In 2024, however, we should have two: Carter Grote and Jacob Driggs. We currently have ten students in confirmation from both Zion and Emmanuel. I anticipate having eight students in Fall 2024.

Dedicated volunteers from both Zion and Emmanuel resumed hosting Vacation Bible School this year from May 22nd through May 24th. I apologize for not having exact numbers, but there were at least forty children in attendance, and the goal is to host another VBS this summer.

Many members of Zion, including Benny Bennight, Sue Kipp, Howard King, and Bob Lamp volunteer many hours to ensure the operation of the Phillips County Food Pantry and the federal commodities program. This ministry is vital to so many in Phillips County.

Zion has opened its doors to the Cub Scouts, the Boy Scouts, the Summer Lunch Program, and to a regular group of people praying for our schools weekly.

I am personally grateful for our council leadership and those who serve on other boards and committees of Zion. Thank you to Steve Rust for serving as council president, Nathaniel Grote as vice president, Shellie Lare as congregation secretary, and Dennis Keesee as treasurer. Thank you to Shellie Lare and Christina Dettmer for completing their first term on council. Thank you to Doug Zillinger for

completing his first term as Parish Council representative at large. Thank you to Janet McCall for her years as WELCA president and Jeff Griffey as the Zion Trust Fund chairman. Thank you to Jean Ann Wagner for her dedication in providing music and worship leadership. Thank you to all those who serve on altar guild, as ushers, as lectors, and as acolytes. Thank you to Howard King and all those who help him with property maintenance. Thank you to Melvin Grau and those who help him keep our cemetery maintained. Thank you to Karin Patton and Deena Lamp in processing Sunday offerings and statements. Thank you to Dennis and Andrea for their janitorial duties. And thank you to all those on committees or who serve in ways that I have neglected to mention.

And then there is you. When you leave worship on Sunday, never forget that you are part of the vital work of Christ. I know the temptation is to try and diminish your importance in your vocation, your family, and in all the ways you become Christ for others. I know it is tempting to say I am too old, too young, too sick. No matter how or where you are, you are the church and the presence of Christ for others. Never forget that.

GOALS AND CHALLENGES IN BEING THE CHURCH

As a congregation, we also need to reflect on goals completed and those that still need to be addressed.

We have successfully updated our constitution and will be voting on changes during this 2024 Annual Meeting on January 21, 2024. This was not an easy task because it had been so long since the last update was done.

We have implemented new church membership software called "Breeze." Breeze is a cloud-based program, so it can be accessed from any computer. Access is also customized so that volunteers can only access those parts for which they are responsible. There is also the possibility of giving every member a log-in credential so that he or she can update their own personal and family information when needed. Breeze also prints custom reports, allows instant printing of picture directories, makes it easier to take attendance, and has donation tracking that can be imported directly into QuickBooks if we wish. So, as we continue to update and gather information, please be patient with us.

Praying for others in our community and in the wider church throughout the world is always an area for growth, but I think we are indeed growing in this area.

Our Lutheran heritage always calls us by the power of the Holy Spirit to rely on God's grace as revealed to us in our savior Jesus Christ. But to do this, we need to more intentional in both individual and community Bible study. This was a goal from last year and we have fallen short. Bible studies still are sparsely attended, and I have not received much help or suggestions for new times, places, or areas of study. So, I remind us that our Zoom Bible Study has returned at 4:00 pm on Sundays. This study is currently focused on the book of Acts. On the second and fourth Thursdays of the month, we have a Bible study at Zion at 7 pm. The focus of this study is currently on Mark. We also have the Daily Lectio Facebook page, which I apologize for not keeping current. My goal is to revitalize this page and encourage more people to participate. I am also open to suggestions as to how we can be more faithful stewards of scripture.

We will continue to encourage confirmation students to attend camp at Tomah Shinga. So far, we have been able to pay for every student who has gone to camp. This year's confirmation camp is June 2nd through June 7th, 2024.

There are currently five youths and four adults registered to attend the 2024 ELCA Youth Gathering in New Orleans, from July 16th through July 20th, 2024. Thank you to all who have supported our efforts and continue to pray and support us as we prepare for this event.

THANKS BE TO GOD THAT WE ARE THE CHURCH

I want to thank Zion and all its members and friends for the privilege of continuing as your pastor. 2023 was my twentieth year of ordained ministry, almost nine of which have been with Disciples of the Plains Lutheran Ministry. I feel we still have a great deal of ministry to do together. May we always point to Christ as the Holy Spirit sends us to serve for the sake of our communities and world.

2023 Zion Education Committee (Formally Congregational Ministry Team)

The Zion Education Committee needs more volunteers for 2024 because right now it is a committee of one. The educational opportunities available are confirmation classes, a Bible study that meets at Zion every second and fourth Thursday evening at 7 pm to study the Gospel of Mark, and a parish-wide Zoom Bible study that meets on Sundays at 4:00 pm that is studying the book of Acts. There is also a Facebook page the parish sponsors called Daily Lectio that offers daily scripture readings.

We were blessed this year with a group of volunteers from Zion and Emmanuel to lead Vacation Bible School here at Zion. Vacation Bible School was a three-day gathering from May 22nd to 24th and featured a game show type theme to encourage following Jesus. Attendance was very good. This was one of the few VBS opportunities in the community during 2023. It is hoped that we continue to provide VBS together as Zion and Emmanuel into 2024.

There were no confirmation students that confirmed their baptisms in 2023.

We currently have ten committed students in confirmation who began their Lutheran Catechism Year in October 2023. Four of these students are from Zion. ZION LUTHERAN CHURCH 2023 TRUST FUND REPORT

Dear Members of Zion,

I am pleased to present to you the 2023 Annual Report for the Zion Lutheran Church Trust Fund. This past year has been a successful one for the trust, and I am grateful to have had the opportunity to serve on the committee alongside Dennis Deschner, Christina Dettmer, and Dennis Keesee, with guidance from Pastor Lee who served as a non-voting member and advisor.

Throughout the year, our committee convened regularly to review grant applications and assess the financial status of the trust. I am delighted to report that the Trust Fund experienced a positive annual return of +6.09%, a testament to the effective management and investment of assets by First National Bank and Trust, especially in the face of the challenging economic climate.

In terms of financial performance, the Trust Fund had a carryover balance of \$6,205 from 2022 and distributed a substantial \$9,117 in 2023, leaving the Trust Fund with \$15,322 to allocate towards 2023 projects. After accounting for project expenses, the remaining balance of \$6,797 will be carried over to FY 2024.

In 2023, the committee approved the following grants: Zion College scholarships (3 students) - \$4,500 Lutheran Disaster Response (Turkey & Syria) - \$1,000 Lutheran Disaster Response (Hawaii) - \$2500 Confirmation Camp - \$525

Total: \$8.525

We are proud to have been able to support these worthy causes and extend our sincere thanks to the members of Zion for their continued support.

Looking ahead, we remain committed to our mission of stewardship and service, and we are optimistic about the future of the Trust Fund. I would like to express my gratitude to everyone involved in making the past year a success and look forward to another year of meaningful contributions and positive impact.
